This ensures that gifts made to FOCCUS are tax deductible and that FOCCUS fulfills its duties and obligations as a U.S. tax-exempt organization under section 501(c)(3) of the Code. Donors may make unrestricted contributions to FOCCUS, and in these cases, the Directors will determine the manner in which contributed funds will be used.
